

Request For Graduate Course Exemption Instructions

Course exemptions are granted only upon approval of the Instructor and the Program Director and are not guaranteed. You must have achieved a grade of B or higher to be considered. Course exemptions do not reduce the total number of credits required for the degree. Each course exemption granted has a Full Course Equivalent (FCE) value that must be replaced with electives totaling the same number of FCEs. Course exemptions have no credit weight.

Please complete one form for each course exemption request. The following documentation is required to be submitted with each form in order for your previous credits to be assessed for course exemption:

- A final copy of your official academic transcript showing grades of courses taken;
- Course description as listed in the university calendar;
- Course outline distributed by the professor in class;
- (if applicable) Copies of assignments (essays, tests, etc.) completed in the course;
- (if applicable) Visual documentation of projects completed in the case of design and representation courses.

Please note that only complete requests will be considered.
